How are you assessed?

- Regular reviews throughout the programme
- Each CIPD unit is assessed via a mix of written methods
- End Point Assessment (EPA) is a work-based project and professional discussion

Additional information

- Candidates without level 2 Maths and English must achieve this prior to completion of their Apprenticeship
- Apprentices or their employers must pay for the student's CIPD membership
- The full apprenticeship will take approximately 3 years
- Employers must commit to supporting the apprentice with 20% of their work time dedicated to off the job and new learning

Funding information

- Levy paying £19000. 100% from levy fund
- Non-levy paying employers contribution of £950
- Additional employer contribution of £800 for CIPD registration and certification
- Additional funding available for 16 18 year olds

Who is delivering the apprenticeship?

Blue Sky Professional Development is working in partnership with Colchester Institute to deliver this HR apprenticeship.

Blue Sky is an approved CIPD centre with experience of delivering CIPD and ILM qualifications at level 3-7. Blue Sky will be responsible for the knowledge element of this apprenticeship via the CIPD qualification.

Colchester Institute is the largest provider of apprenticeships in Essex. The Institute will be responsible for reviewing apprentices' progress and supporting the embedding of skills and behaviours via coaches (remote) visiting the workplace, as well as End Point Assessment. Colchester Institute can also help with funding queries.
